# Interim Action Ranges Field Activities

The Interim Action Ranges Munitions Response Area (MRA) falls within the jurisdictional boundaries of Monterey County and a small portion of the City of Seaside. Historically this land was used for military weapons and live-fire training, including mortars, anti-tank rockets, and 40 mm grenades. Army investigations and removal actions took place between 1997 and 2007. Future uses for the Interim Action Ranges will consist of Habitat Reserve and Development, specifically the Monterey Peninsula College Police Officer Training Facility.

The Army and the ESCA RP Team found evidence of sensitively fuzed munitions within the Interim Action Ranges MRA, which has lead to a Design Study approach that is currently being conducted on the MRA. The goal of the Design Study is to determine if additional actions are necessary to meet the objectives of the Interim Action Record of Decision (ROD) and support a final remedial action decision for the area.

The Design Study activities include digital geophysical mapping (DGM), brush cutting, field investigation using analog and digital equipment, and recovery of items found – some of these activities are illustrated in the site photos above. The Design Study data results have led the ESCA RP Team to conduct additional field investigations in one area as part of the Interim Remedial Actions.

A Habitat Restoration Plan is being developed by the ESCA RP team in coordination with the U.S. Army and the U.S. Fish and Wildlife Service. This plan will be in accordance with the Biological Opinions and the Base Wide Habitat Management Plan and address the restoration requirements in the Interim Action Range MRA.



## Parker Flats Field Activity Update

The 1,180 acre Parker Flats Munitions Response Area (MRA) is planned for a mix of uses, including 182 acres proposed for future residential reuse. The future residential reuse areas are currently undergoing the Residential Quality Assurance (RQA) process, which was developed under the FORA ESCA Remediation Program to evaluate MEC hazards resulting from historical Army training activities. The goal of the RQA process is to simultaneously be protective of human health and safety (such as recreationalists and future users) as well as to minimize the amount of vegetation removal necessary for intrusive digging and investigation to meet EPA and DTSC regulatory requirements. In the first quarter of 2012, RQA work will be performed along Parker Flats Road and two other areas as shown in the adjacent figure.

At the ESCA Remediation Program September 2011 Informal Community Workshop, the Team provided an in-depth description of the Parker Flats RQA work to date. The RQA Evaluation phase (Level 1) was performed in the future residential reuse areas (see blue areas on the figure) and completed in August 2011. Based on the evaluation, the data indicated that, out of 182 acres, additional investigation is required in 12 acres along and to the north of Parker Flats Road due to the possible historical use of 37mm projectiles, concerns with detection capabilities of original survey instruments, and the discovery of high hazard munitions. These areas, indicated in red, will be addressed with the next RQA phase, Level 2, requiring vegetation removal and further investigation. On the remaining 170 acres (identified in blue) no remedial action or vegetation removal will be necessary. A

### **KEEPING IT SAFE**

Maintaining safety for the public and the unexploded ordnance technicians is a top priority for the FORA ESCA RP team. To help ensure safety, public access onto ESCA lands is restricted. Vehicle entrance is for official ESCA business only. You can easily recognize an official ESCA vehicle by the decals.

Army personnel, BLM workers and volunteers, utility workers, surveyors, event organizers (such as the Sea Otter Classic and Fort Ord Mud Run), and others may apply for vehicle access permits in order to access ESCA property, but note that permits are issued at the discretion of FORA.

Because portions of the ESCA property are restricted. Access Corridors have established for recreationalists been and private citizens to traverse ESCA property onto BLM trails. Vehicle access permits must be prominently displayed on the dashboard at all times. If you see a vehicle on ESCA property without the required permit, or without the visible decal on the vehicle, for your safety, do not intervene. Note the vehicle location and contact FORA right away at the contact information above.
